FIELD NOTES FOR A 20' WIDE ELECTRICAL EASEMENT

BEING 0.760 ACRES OF LAND OUT OF THAT 38.04 ACRES OF LAND DESCRIBED AS TRACT NO. 2 AS CONVEYED IN GENERAL WARRANTY DEED RECORDED IN VOLUME 3657, PAGE 44 OFFICIAL PUBLIC RECORDS OF HAYS COUNTY, TEXAS, (O.P.R.H.C.TX.) AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

COMMENCING at a found ½ inch iron rod, accepted as the Southeast corner of Lot 6, Block J, of Amended Plat of Cottonwood Creek, Phase 1, Section 1-D, a subdivision recorded as Instrument No.: 2013-13029482, O.P.R.H.C.TX., said point also being accepted as a point in the Northerly line of said Tract No. 2 and being accepted as a point in the centerline of a 60 foot wide access and Public Utility Easement, (P.U.E.) dedicated on Final Plat of Cottonwood Creek, Phase 1, Section 1-A a subdivision recorded in Volume 12, Pages 313-318, Plat Records, Hays County, Texas, (P.R.H.C.TX.);

THENCE S 26° 34' 09" W, 160.14 feet along the Northerly line of said Tract No. 2 to a point of intersection with the Southerly limits of a 50 foot wide access and P.U.E. area dedicated on said Section 1-A subdivision;

THENCE S 63° 26' 24" E, 20.00 feet leaving the Northerly line of said Tract No. 2 and entering into the interior of said Tract No. 2 to a point of intersection with a line being parallel with and 20.00 feet Southerly of said Northerly line of Tract No. 2 said point being the TRUE POINT OF BEGINNING hereon also being accepted as a point in the Southerly limits of a 20.00 foot waste water easement area not yet recorded;

THENCE Southwesterly and Westerly along said parallel line of the following three (3) courses;

- 1. S 26° 34′ 09" W, 211.61 feet to the beginning of a curve concave Northwesterly and having a radius of 735.00 feet:
- 2. Southwesterly along said curve through a central angle of 50° 03' 21" an arc length of 642.12 feet to the end of said curve, a chord bearing and distance of S 51° 35' 49" W, 621.90 feet to the end of said curve;
- 3. S 76° 37' 29" W, 793.33 feet to a point of intersection with the Easterly limits of a 10.00 foot wide P.U.E. are dedicated on Cottonwood Creek, Phase 1, Section 2, subdivision, not yet recorded;

THENCE S 13° 22' 31" E, 20.00 feet leaving said parallel line along said P.U.E. of said Section 2 subdivision to a point of intersection with a line being parallel with and 40.00 feet Southerly of said Tract No. 2;

THENCE Easterly, Northeasterly and Northerly along said parallel line of the following three (3) courses;

- 1. N 76° 37' 29" E, 793.33 feet to the beginning of a curve concave Northwesterly and having a radius of 755.00 feet;
- 2. Northeasterly along said curve through a central angle of 50° 03' 21" an arc length of 659.60 feet to the end of said curve, a chord bearing and distance of N 51° 35' 49" E, 638.82 feet to the end of said curve;
- 3. N 26° 34' 09" E, 211.61 feet;

THENCE leaving said parallel line N 63° 25' 51" W, 20.00 feet to the POINT OF BEGINNING hereof, containing a calculated area of 33,116.11 sq. ft., 0.760 acres, said field notes being described in accordance with a survey made on the ground by me or under my direction and shown on EXHIBIT "A" TWO OF TWO 20 foot wide Electrical Easement Sketch attached hereto and made a part hereof.

All bearings shown are based on NAD 83 Texas State Plane Coordinate System, South Central Zone. All distances shown are surface or ground distances.




