Consider approval of Ordinance 2023-37, on the second of two readings, approving

TMP-23-01, amending the City's Transportation Master Plan, Appendix E (Roadway), Appendix G (Bicycle Plan), and Appendix H (Greenways Plan) to remove the extension of McCoy Drive from McCoy Circle to Davis Lane, to remove a future avenue from River Road across the subject property to Davis Lane, and to remove a portion of the proposed greenway adjacent to the applicant's property; and including procedural provisions; and providing an effective date.

- 5. Consider approval of Ordinance 2023-38, on the second of two readings, amending the Official Zoning Map of the City in Case No. ZC-23-03, by rezoning approximately 67.121 acres of land out of the Edward Burleson Survey, No. 18, Abstract No. 63 in Hays County, Texas, located at and near 3830 South IH 35 (Centerpoint and IH 35), from "FD" Future Development and "LI" Light Industrial to "CD-5" Character District 5, or, subject to consent of the owner, another less intense zoning district classification, including procedural provisions.
- 6. Consider approval of Resolution 2023-87R, authorizing Change in Services to agreements between the City and Atrium Real Estate Services, BBG, Inc., and the AEGIS Group, Inc. for the provision of additional on-call professional appraisal services in connection with the City's real estate projects; increasing the original contract amounts in each agreement from \$100,000.00 to \$300,000; authorizing the City Manager or her designee to execute the Changes in Services; and declaring an effective date.
- 7. Consider approval of Resolution 2023-88R, supporting the City's application for the San Marcos Shared Use Pathway project to the Texas Department of Transportation's 2023 Transportation Alternatives Set-aside (TA) call for projects; and declaring an effective date.
- 8. Consider approval of Resolution 2023-89R, supporting the City's application for the Purgatory Creek Improvements Trails project to the Texas Department of Transportation's 2023 Transportation Alternatives Set-aside (TA) call for projects; and declaring an effective date.
- 9. Consider approval of Resolution 2023-90R, supporting the City's application for the Old Ranch Road 12 Bike and Pedestrian Widening Project to the Texas Department of Transportation's 2023 Transportation Alternatives Set-aside (TA) call for projects with required local match; authorizing the City Manager or her designee to execute all documents necessary for the application for these funds; and declaring an effective date.
- 10. Consider approval of Resolution 2023-91R, authorizing the use of the power of Eminent Domain to acquire a 1.501 acre wastewater line easement as depicted in the exhibit "A" attached hereto and incorporated herein for all purposes; determining the public necessity for this acquisition to advance and achieve the public use of the Staples Road Wastewater Improvements Project to extend public wastewater lines to provide wastewater services to the area south and east of the intersection of Staples Road and Old Bastrop Highway; authorizing the City Manager, or her designee, to take all steps necessary to acquire the needed interest in the property in compliance with all applicable laws; authorizing the City Attorney or his designee to institute condemnation proceedings as necessary to acquire said property interests to the extent negotiations are unsuccessful; and declaring an effective date.

- 11. Consider approval of Resolution 2023-92R, approving a renewal for a term of one year of the License Agreement with Skinny Labs, Inc., doing business as SPIN, that enables SPIN's shared micro-mobility devices such as electric scooters to be operated within city rights-of-way; authorizing the City Manager, or her designee, to execute said renewal on behalf of the City; and declaring an effective date.
- 12. Consider approval of Resolution 2023-93R, approving an Advance Funding Agreement with the State of Texas, acting through the Texas Department of Transportation ("TXDOT"), for the construction of the Highway Safety Improvement Program Grant Improvements for the roadway resurfacing of Sessom Drive from Alamo Street to University Drive ("Loop 82") with an estimated city participation amount of \$116,290.00 plus 100 percent of any cost overruns; authorizing the City Manager, or her designee, to execute said agreement on behalf of the City; and declaring an effective date.
- 13. Consider approval of Resolution 2023-94R, approving a contract with First United Methodist Church of San Marcos for the purchase of approximately 0.23 of an acre (10,163 square feet) for public right of way and the fee simple purchase of 0.10 acre (4,346 square feet), as detailed in exhibit "A" attached hereto and incorporated herein for all purposes, near the intersection of North Guadalupe Street and University Drive at a price of \$900,439.00, plus related closing costs; authorizing the City Manager, or her designee, to execute said contract and all closing documents related to such purchase on behalf of the city; and declaring an effective date.

Consider approval of Resolution 2023-95R, approving the procurement of NeoGov Applicant Tracking Software System licenses, support, and maintenance from SHI Government Solutions through Omnia Partners Cooperative for a total amount not to exceed \$107,133.10 per year with the option of renew once a year for up to two years for a total amount not to exceed \$321,399.30; authorizing the City Manager or her designee, to execute the appropriate purchase documents on behalf of the City; and declaring an effective date.
