## **RESOLUTION NO. 2021-127R**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS ALLOCATING GENERAL FUND DOLLARS MADE AVAILABLE DUE TO THE AWARD TO THE CITY OF CARES ACT CORONAVIRUS RELIEF FUNDS; AUTHORIZING THE CITY MANAGER TO ACT AS THE OFFICIAL REPRESENTATIVE OF THE CITY IN MATTERS RELATED TO SAID FUNDS ON BEHALF OF THE CITY; AND DECLARING AN EFFECTIVE DATE.

## **RECITALS:**

- 1. Through Resolution 2021-67R, on April 20, 2021, the City Council designated categories and criteria for the use of general funds made available duet to the award to the City of CARES Act Coronavirus Relief Funds; and
  - 2. Through that allocation \$640,000 was made available as a One Time Grant Fund.

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS:

- **PART 1.** The allocation of the One Time Grant Fund, consisting of general fund dollars made available due to the award to the City of CARES Act Coronavirus Relief Funds, in the amount of \$640,000 as set forth in Exhibit A, is approved. Funding is allocated to the agencies in the amounts listed, and the remainder is allocated to the Human Services Grant Fund for use in the 2021 application process.
- **PART 2**. The restriction that the use of funds must be related to the COVID-19 Pandemic is hereby removed from the amount allocated to the Human Services Grant Fund.
- **PART 3.** The City Manager, or his designee, is authorized to act as the official representative of the City in matters related to said funds.
- **PART 4.** This resolution shall be in full force and effect immediately from and after its passage.
