## Notification of Proposed Annexation by the City of San Marcos – AN-23-05 (Oak Creek Annexation)

Dear Public Entity Representative:

Under Local Government Code Chapter 43, cities are required to notify certain public entities of all proposed annexations. The San Marcos City Council is considering the following annexations that may affect your jurisdiction:

Annexation of a 29.91 +/- acre tract of land out of the Cyrus Wickson Survey, Abstract Number 474; the John Frederick Geister Survey, Abstract Number 203; the Farnham Frye Survey, Abstract Number 183, and the Rebecca Brown Survey, Abstract Number 46, in Hays County, Texas, generally located at 2409 Old Bastrop Highway.

All annexations are subject to notification, public hearings, and vote by City Council. The annexation schedule is as follows:




