They also noted that he was displaying aggressive body language indicating that he would like to fight them. They refused entry to the subject. The subject took a swing at one of the staff and pulled the other subject to the ground. That staff member received a laceration to the head and a potential dislocated shoulder. Review of the business video supported the report made to officers and the subject was arrested.

The officer explained that these types of noise issues should be addressed with the owner and management company of the building due to lease requirements for living above a bar. No enforcement action taken.

Bar staff broke up the fight and physically escorted the subjects out of the bar.
