## **RESOLUTION NO. 2017-**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS, PROVIDING PUBLIC RECOGNITION OF VOTES NOT PREVIOUSLY COUNTED OR INCLUDED IN THE OFFICIAL CANVASS OF THE GENERAL ELECTION, HELD ON NOVEMBER 8, 2016, FOR THE PURPOSE OF ELECTING A MAYOR, CITY COUNCIL MEMBER, PLACE ONE, CITY COUNCIL MEMBER, PLACE TWO, AND THE CONCURRENT SPECIAL ELECTION TO FILL A VACANCY FOR THE ONE YEAR REMAINDER OF THE UNEXPIRED TERM OF CITY COUNCIL MEMBER PLACE THREE; AND PROVIDING AN EFECTIVE DATE

## **RECITALS:**

1. On August 16, 2016 the City Council adopted Ordinance No. 2016-32 ordering a general and special election to be held on November 8, 2016 for the purpose of electing a Mayor, City Council Member, Place One, City Council Member, Place Two, and to fill a vacancy for the one year remainder of the unexpired term of City Council Member, Place Three.

2. The City Council of the City of San Marcos, Texas convened on November 21, 2016 to consider the returns of the General and Special election held on November 8, 2016. Council approved Ordinance No. 2016-53 on that date as the official canvass of the election returns.

3. At the time of the official canvass, the City Council was not aware that votes cast in a Mobile Ballot Box had not been tallied.

3. On February 22, 2016 Hays County Elections Administrator, Jennifer Anderson, released a statement regarding the discovery of one Mobile Ballot Box that was not tallied in the November 8, 2016 election.

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS:

**PART 1.** The City Council of the City of San Marcos hereby publicly recognizes the previously uncounted votes cast in the November 8, 2016 election and further recognizes the new unofficial vote totals resulting from inclusion of those vote as follows:
