STATE USE CONTRACT

This Contract for vegetation and litter control is entered into by and between the Receiving Party and the Performing Party, based upon negotiated price and specifications and certified by TIBH Industries, Inc., as a contract under the provisions of Chapter 122 of the Human Resources Code.

AGREEMENT

In consideration of the premises and of the mutual covenants and agreements of the parties hereto to be by them respectively kept and performed as hereinafter set forth, it is agreed as follows:

ARTICLE 1. CONTRACTING PARTIES

Receiving Party: City of San Marcos, Texas Performing Party: Easter Seals – Central Texas

Certifying Party: TIBH Industries, Inc.

ARTICLE 2. CONTRACT PERIOD

The contract period for this Agreement begins on October 1, 2017, and will end on September 30, 2018.

ARTICLE 3. SERVICES TO BE PERFORMED

The Performing Party will perform the following services:

The Performing Party will observe all safety requirements established by the Texas Department of Transportation during the pick-up process. In addition, the Performing Party will haul all trash to the City's facility on River Road and will provide all necessary equipment to accomplish its services. In those areas that require the use of a mower, the height of the blades will be set at a maximum of two (2) to three (3) inches. For those areas requiring the use of weedeaters, the Performing Party will strive to maintain a uniform height of approximately four (4) inches. In addition, the Performing Party will chip all wooded material at the City's compost site and make use of the existing roll-off container provided by the City. These services are to be performed in locations identified by the Receiving Party. The Performing Party will perform all services in accordance with the descriptions contained in this Agreement and as further detailed in Attachment A. The schedule for work identified in this Agreement is tentative. Should the Receiving Party wish to modify this schedule, the Performing Party will adjust the schedule to meet the Receiving Party's needs.

ARTICLE 4. CONTRACT AMOUNT

The total amount to be paid by the Receiving Party to the Performing Party for services under this contract will be the annual sum of \$1,110,238.67, in accordance with **Attachment A.** Should the Performing Party be required to haul materials to a disposal location other than the City's compost site, the City will be billed at a rate of \$16.50 per cubic yard.

ARTICLE 5. PAYMENT FOR SERVICES

The Receiving Party will pay TIBH Industries, Inc., as assignee and servicing agent of the Performing Party's interest in the payment under this contract (as directed) for goods and services received. Upon receipt of a proper invoice or voucher submitted by TIBH Industries, Inc., such payment will be made within thirty (30) calendar days from receipt of same.

Payment by the Receiving Party to TIBH Industries, Inc., as assignee to the Performing Party will be based upon bills presented monthly, with billing based upon the actual performance of the specified work by location.

ARTICLE 6. TERMINATION

This Agreement may be terminated under any one of the following conditions:

a) By mutual agreement and consent of both parties.

- b) By the Receiving Party giving written notice to the Performing Party and the Certifying Party as a consequence of failure by the Performing Party to satisfactorily perform the services and obligations set forth in this Agreement, with proper allowances being made for circumstances beyond the control of the Performing Party.
- c) By either party upon thirty (30) calendar days written notice to the other.

ARTICLE 7. REMEDIES

Violation or breach of contract terms by the Performing Party will be grounds for termination of this Agreement, and any increased costs arising from the Performing Party's default, breach of contract, or violation of terms will be paid by the Performing Party. This Agreement will not be considered as specifying the exclusive remedy for any default, but all remedies existing at law and in equity may be availed of by either party and will be cumulative.

ARTICLE 8. SUBLETTING

The Performing Party will not sublet or transfer any portion of its responsibilities and obligations under this Agreement unless specifically authorized to do so in writing by the Receiving Party.

ARTICLE 9. SUCCESSORS AND ASSIGNS

The Performing Party will not assign or otherwise transfer its rights or obligations under this Agreement except with the prior written consent of the Receiving Party.

ARTICLE 10. LEGAL CONSTRUCTION

In the event that any one or more of the provisions contained in this Agreement will for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability will not affect any other provisions thereof and this Agreement will be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.

ARTICLE 11. GOVERNING LAWS AND VENUE

This Agreement will be construed under and in accordance with the laws of the State of Texas. Any legal actions regarding the parties' obligations and any matters whatsoever arising from this Agreement will be filed and maintained in Hays County, Texas.

ARTICLE 12. PRIOR AGREEMENTS SUPERSEDED

This Agreement constitutes the sole and only agreement of the parties hereto and supersedes any prior understandings or written or oral agreements between the parties respecting to this subject matter.

ARTICLE 13. FUNDING OUT

As applicable to this Agreement, the Performing Party understands that funds for the payment for work performed by the Performing Party under this Agreement have been provided through the City's budget approved by the City Council for the current fiscal year only. State statutes prohibit the obligation and expenditure of public funds beyond the fiscal year for which a budget has been approved. The City cannot guarantee the availability of funds and enters into this Agreement only to the extent such funds are made available. The Performing Party acknowledges and agrees that it will have no recourse against the City for its failure to appropriate funds for the purposes for this Agreement in any fiscal year other than the year in which this Agreement was executed. The fiscal year for the City extends from October 1st of each calendar year to September 30th of the following calendar year.

ARTICLE 14. INSURANCE AND INDEMNITY

The Performing Party will hold harmless, indemnify, and defend the Receiving Party and its employees, agents, officers, and servants from any and all lawsuits, claims, demands, and causes of action of any kind arising from the negligent or intentional acts, errors, or omissions of the Performing Party, its officers, employees, or agents. This will include, but not be limited to, the amounts of judgments, penalties, interest, court costs, reasonable legal fees, and all other expenses incurred by the Receiving Party in favor or any party, including the amounts of any damages or awards resulting from claims, demands, and causes of action for personal injuries, death, or damages to property.

The Performing Party will procure and maintain, at its expense, insurance with insurance companies authorized to do business in the State of Texas, covering all operations under this Agreement, whether performed by the Performing Party or its agents, subcontractors, or employees. Before commencing the work, the Performing Party will furnish to the Receiving Party a certificate or certificates in a form satisfactory to the Receiving Party showing that the Performing Party has complied with this paragraph. All certificates will provide that the policy will not be changed or cancelled until at least thirty (30) calendar days written notice will have been given to the Receiving Party. Commercial general liability insurance and motor vehicle insurance will be written with the City of San Marcos, Texas, as an additional insured and will be endorsed to provide a waiver of the carrier's right of subrogation against the City. The kinds and amounts of insurance required are as follows:

<u>Workers' Compensation Insurance</u>: In accordance with the provisions of the Workers' Compensation Act of the State of Texas.

<u>Liability Insurance</u>: (1) Commercial general liability insurance with a combined single limit of \$1,000,000 for each occurrence and \$1,000,000 in the aggregate; and (2) motor vehicle liability insurance in an amount not less than \$1,000,000 for injuries to any one person, \$1,000,000 on account of any one accident, and in an amount of not less than \$1,000,000 for property damage.

The stated limits of insurance required by this Paragraph are **minimum only** and it will be the Performing Party's responsibility to determine what limits are adequate. These limits may be met by basic policy limits or any combination of basic limits and umbrella limits. The Receiving

Party's acceptance of certificates of insurance that do not comply with these requirements in any respect does not release the Performing Party from compliance with these requirements.

ARTICLE 15. NOTICE TO PARTIES

Notice to be effective under this contract must be in writing and received by the party against whom it is to operate. Notice is received by a party as follows: (1) when it is delivered to the party personally; (2) on the date shown on the return receipt if mailed by registered or certified mail, return receipt requested, to the party's address specified in this Article 15 and signed on behalf of the party; or (3) three business days after its deposit in the United States mail, with first-class postage affixed, addressed to the party's address specified in this Article 15. Any party may change its address by providing notice of such change in accordance with the requirements of this Article 15.

This Agreement represents the entire Agreement of the parties, and an amendment to it is not effective for any purpose unless in writing and signed by all parties.

This contract is binding on and inures to the benefit of the parties' successors in interest.

Dear Mr. Claybourn:

We would like to submit our proposed rate and amendments increase to the FY2017 Vegetation Control, Debris Removal, and Landscape Maintenance Contract, for the upcoming FY2018 service contract.

The proposed rate increase from the current FY2017 contract to the new FY2018 contract is \$11,470.13. This rate change increases the total contract cost to \$1,054,536.53

The proposed amendments increase the new FY 2018 contract by \$55,702.14. The amendments to the new FY2018 contract are as follows:

- --Add 66 cycles of mowing the soccer fields at the 5 Mile Dam Complex. This is a new mowing service. Cost will be \$437.61 per cycle for a total increase to the contract of \$28,882.26.
- --Add 24 cycles of mowing, trimming, and maintenance, to the flower beds in the non-playing area of the 5 Mile Dam Complex. This is a new service. Cost will be \$794.33 per cycle for a total increase to the contract of \$19,063.92.
- --Add 6 cycles of mowing at Blanco Shoals. To include four river access cuts, two on both sides of the river for a cost of \$1,292.66 per cycle. The total cost increase for this service is \$7,755.96.

The total proposed service cost for the FY2018 Vegetation Control, Debris Removal, and Landscape Maintenance Contract will be \$1,110,238.67.

We will run the Tenant Sweepers or blow the sidewalks and parking areas around the square (only) 4 days a week (Monday, Tuesday, Thursday, and Friday). We will also clean trash from the Flower Beds and empty ash trays. We will clean and blow to the street for the Sweeper to clean up: all trash and debris along curbs and sidewalks in an expanded area.

Area A consists of a 4 block area bordered by Hopkins on the South, University on the North, Guadalupe on the West, and Edward Gary on the East. This area will be cleaned on Mondays and Thursdays
