Charles Johnson, 304 Suttles Ave. spoke in favor of the request. He spoke on behalf of First Baptist Church and their views. He says that Halcyon understands the church's vision for elderly care. He insists they do not want to see the development of a public road through the development.

Beth Knox, 206 W. Mimosa Circle, does not want to see a public street through the proposed Halcyon PDD. She suggests that the inclusion of any public thoroughfare compromises the fulfillment of Halcyon's mission to emphasize quality of life in a safe, supportive environment.

Marian Upchurch, 1308 Mustang Ln., does not approve of a public street in a community that is designed for seniors. She says the should be able to walk and cross the streets

without a fear of cars.
