



#### **Kyle Wooten, Safety Compliance/Operations Officer**



# PROJECT APPROACH & SAFETY

Pyro Shows of Texas is committed to and demonstrates the company philosophy of safety excellence. Pyro Shows has adhered to stringent safety practices while providing fireworks entertainment throughout the world for 47 years. Pyro Shows owner and CEO, Lansden E. Hill, Jr., has served as an active member on the Technical Committee of the National Fire Protection Association (NFPA) since the late 1980's.

## **Safety**

The show crew leader assigned for the City of San Marcos Summerfest show, will be a certified pyrotechnician that has passed State examinations and maintained continuing safety education training.

- The crew leader will be a technician experienced working on shows of equal and greater size.
- The entire crew will be in compliance with NFPA 1123 regulations wearing cotton clothing during set-up of the show. They will also wear head, ear, and eye protection during the firing of the show.
- The crew leader and technicians will all be cleared by the Bureau of Alcohol, Tobacco, Firearms and Explosives (BATFE) with a criminal background check as required by the Employee Possessor Questionnaire forms.
- The crew will confirm that a safety zone with a 420' radius clearance from all buildings and personnel has been marked. It will be the decision of the City Fire Marshal at what time to begin enforcing the 420' radius.
- The crew will mark a secure work area having a radius of 100' in which the footprint of the show will be built.
- Pyro Shows crew will observe the "smoke free" ordinance of the City of San Marcos. There will be
  no smoking on the City property (including e-cigarettes and other inhaled vapor devices) and "no
  smoking" signs will be posted at the crew work site.
- After the site is secured the crew will begin off-loading all of the equipment necessary to produce the "Summerfest" fireworks show. The crew will construct all mortars 6-inch and smaller with 2" x 4" x 3" supports. There will be four (4) of these supports per set-up. This surpasses the NFPA 1123 code for construction of fireworks set-ups.
- After all construction is complete and inspected by the crew leader, the loading of fireworks ordnance will begin. The Pyro Shows truck will always be parked with the back of the truck facing in a direction away from Pyro Shows workers and any other personnel working the area as per NFPA 1123.
- All construction and wiring should be completed by 4:00 p.m. on July 4, 2017.
- Before the firing of the show, the Pyro Shows crew will check the 420' safety zone to ensure it is clear. During the firing of the show, Pyro Shows will have 4 technicians that will fire the show and monitor the display. This is in compliance with NFPA 1123.



# PROJECT APPROACH & SAFETY (cont.)

- Upon completion of the show the Pyro Shows crew will do a thorough sweep of the safety zone to
  ensure there is no undetonated ordnance in the zone. The crew will also check each mortar to
  ensure all ordnance has been discharged. If any live ordnance is found it will be inspected and
  disposed of according to NFPA 1123.
- After determining that all ordnance is either discharged or accounted for, the Pyro Shows' crew will begin its cleanup process. The Pyro Shows crew will restore the work site back to its original status.
- Pyro Shows crew will complete a walkthrough of the site one final time the following morning of the display in accordance with NFPA 1123 standards.






# **AERIAL SHELL INFORMATION**
