

ORDINANCE NO. 2018-45

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS, AMENDING ORDINANCE 2018-23 ORDERING A GENERAL AND SPECIAL ELECTION TO BE HELD ON NOVEMBER 6, 2018 BY AMENDING THE POLLING LOCATIONS FOR ELECTION DAY VOTING; AND AMENDING THE LOCATIONS, DATES AND TIMES FOR EARLY VOTING BY PERSONAL APPEARANCE; AND DECLARING AN EMERGENCY CREATING THE NEED TO ADOPT THIS ORDINANCE WITH ONLY ONE READING; AND PROVIDING AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS:

SECTION 1. That Section 2 of Ordinance 2018-23, setting forth the polling place locations and the dates and times for election day voting in the General and Special City Election, is hereby amended by relocating the Precinct 334 election day polling location, which is currently consolidated with Precincts 330 and 318, to Texas State University, LBJ Student Center, 700 Student Center Drive, San Marcos, Texas 78666. The polling places for each precinct for this election shall now be as follows:

SECTION 2. That Section 7 of Ordinance 2018-23, setting forth the polling place locations and the dates and times for early voting in the General and Special City Election, is

hereby amended by adding an additional two days of voting at Live Oak/Health Department, Texas State University, and to add Belterra Welcome Center as an early voting location as follows:
