History

- 2014 Affordable Housing Policy Adopted
- 2016 City begins conversation with proposed development
- 2017 Policy amended to include criteria for Low Income Housing Tax Credit Policy (LIHTC) for large multifamily developments reserved for 55+ communities
- 2018 Policy amended to remove language regarding 55+ communities and added minimum criteria
 - Applications <u>must meet 5 out of the 8 criteria</u> in order to receive a staff recommendation of support.

Based on the criteria outlined in the Affordable Housing Policy, the application meets **2 out of the 8 criteria.**



Alternative Recommendation

If the City Council chooses to recommend approval of the application, staff recommends that the following conditions be added:

- 1. The Applicant must comply with all City of San Marcos rules and regulations governing the development of the Project including, but not limited durable building materials, environmental protection, connectivity, site and building design requirements, and all applicable standards and regulations within the City's Code of Ordinances including requirements for submission of required applications and payment of applicable fees; and
- 2. The Applicant may not apply for and the Project will not be eligible to receive any variances from any applicable City of San Marcos ordinances, rules or regulations.
