I. Call To Order

With a quorum present, the regular meeting of the San Marcos City Council was called to order by Mayor Hughson at 6:00 p.m. Tuesday, February 18, 2020 in the City Council Chambers, 630 E. Hopkins, San Marcos, Texas 78666.

II. Roll Call

Council Member Marquez was absent due to business travel.

III. Invocation

Pastor Dr. Chad R. Chaddick, with First Baptist Church provided the invocation this evening.

IV. Pledges of Allegiance - United States and Texas

Theodore Gonzales, 3rd grade student at San Marcos Preparatory School, led the assembly in the pledges of allegiance.

V. 30 Minute Citizen Comment Period

Kimberly Meitzen, spoke on item #7, on behalf of the Franklin Square Homeowners Associations. Ms. Meitzen asked the City to accept the land donation on behalf of their HOA. The Homeowners Association is in the process of dissolving their HOA and this 5 acre tract provides greenspace. They would be grateful if you accepted this and add it to greenspace for the City.

Lisa Marie Coppoletta, stated that she loved the opening prayer regarding the Golden Rule. She claimed this never happened under several previous Mayors and only four times under Mayor Thomaides. She continued to state that under this administration, citizens are interrupted and the Mayor feels the need to correct them. She kindly asked the Mayor to please refrain from

commenting. She stated that we do have three Assistant City Managers and that her statement was correct from the last Council meeting. She mentioned the letter that her neighbors received on speed bumps and neighbors on the other side of Belvin are being ignored. She claims Mr. Lumbreras will not place a public sidewalk in his staff's neighborhood. She stated that an employee who works in the street department has a private sidewalk. Ms. Coppoletta believes that her street has a speed trap because Mr. Lumbreras is protecting his own city employees who don't want a sidewalk.

Roland Saucedo, thanked Council for their service. He spoke on items #13 and 14. He applauds the steps taken towards the no objection for housing tax credits. Stated he is still concerned and would like to see Small Area Plans finalized, it is part of Land Development Code and there is no plan. Secondly, Small Area Plans were there to protect the neighborhoods. We have a couple of neighborhoods that are being invaded with stealth dorms. Mr. Saucedo asked Council to bring forward this year and make the Small Area Plan a priority. He asked they finalize the task force affordable housing action plan that was proposed by the committee. There is concern from the members of the task force that Council may not be satisfied with the work they completed. Please approve of the renaming of El Camino Real Park to Officer Kenneth Copeland Memorial Park.

Receive a Staff presentation and hold a Public Hearing to receive comments for or against Ordinance 2020-05, annexing into the City approximately 56.923 acres of land out of the John Williams Survey, Abstract 490, Hays County, being Phase 1, Section 2 of the La Cima Development, generally located west of the intersection of Old Ranch Road 12 and Wonder World Drive; including procedural provisions; and providing an effective date; and consider approval of Ordinance 2020-05, on the first of two readings.

Shannon Mattingly, provided Council with a presentation and explained this is a request for voluntary annexation in the La Cima subdivision and proposal is single family residential. This is part of the original plan and they request annexation as new plats are approved.

Mayor Hughson opened the Public Hearing at 6:27 p.m.

Those who spoke:

Roland Saucedo, expressed his support of this annexation. The decision made today will increase revenue for the City with utility services and taxes. He expressed his concern of the excess traffic that will be on Ranch Road 12 and Wonder World with this development. He hopes traffic studies are being done to address this.

Shannon Mattingly, Director of Planning and Development Services, provided a brief presentation.

Eric Willis, manager of the project, stated this is the second phase of La Cima and explained these are larger lots with a quarter acre or a little more. He spoke on traffic and plans to complete the buildout and this will create deacceleration and acceleration lanes at intersection of Old RR12 and Wonder World, those plans are to be done all at one time. They will continue to work with TxDOT and the City to improve the entire intersection.

Roland Saucedo, supports this request, likes what they have done so far and the contributions to the community, for example, sponsoring the Mermaid Society. Not only developing in our community but also giving back to the community. He thanked them for addressing the concerns of traffic. This increases housing stock, perhaps there is some kind of opportunity that some of these houses can reach our affordable housing working demographics.

The new section will now read:

The project incorporates wraparound support services that provide flexible voluntary social, economic,

or education benefits to the residents. The project shall meet the following criteria and will be

considered in the analysis of whether criteria 8 is met:

- a. Proposed support services shall meet the needs of the local community;
- b. The project shall utilize local support services and resources;
- c. The project shall exceed the minimum TDHCA requirements for amenities;
- d. The project shall submit to the City the Project's TDHCA Application for Low Income Housing Tax Credits and includes the list of amenities in the Project's Land Use Restriction Agreement (LURA).
- e. The project shall submit surety documentation to the City that the proposed support services will be included in the completed project. Projects will be required to submit documentation such as a Memorandum of Understanding (MOU) or any other legal documentation indicating the partnership between the project and the support service. Such documentation shall be required prior to the issuance of a Certificate of Occupancy for the project.
