ORDINANCE NO. 2020-85

CONSIDER APPROVAL OF ORDINANCE 2020-85, AMENDING ORDINANCE 2020-81 BY AMENDING THE TIME AND LOCATIONS FOR EARLY VOTING AND ELECTION DAY FOR A RUNOFF ELECTION TO BE HELD ON DECEMBER 8, 2020 FOR THE POSITION OF MAYOR AND THE ONE YEAR REMAINDER OF THE UNEXPIRED TERM OF COUNCIL MEMBER PLACE 5; MAKING PROVISIONS FOR CONDUCTING THE ELECTION; DECLARING AN EMERGENCY CREATING THE NEED TO ADOPT THIS ORDINANCE WITH ONLY ONE READING; AND PROVIDING AN EFFECTIVE DATE.

RECITALS:

- 1. On November 16, 2020 the City Council adopted Ordinance No. 2020-81, that canvassed returns and declared results of the General Election held on November 3, 2020 and established Early voting and Election Day Polling Locations for a runoff election to be held on December 8, 2020 for the position of Mayor and the one year remainder of the unexpired term of Council Member Place 5
- 2. It has become necessary to amend Ordinance No. 2020-81 to revise the time and locations for early voting and election day voting for the runoff election as set forth below in this ordinance.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS:

SECTION 1. Ordinance No. 2020-81 is hereby amended by amending Section 6 thereof, pertaining to Election Day voting for the December 8, 2020 runoff election, to read as follows:

"SECTION 6. On Election Day, eligible City of San Marcos voters may vote at any of the locations listed below from 7:00 a.m. to 7:00 p.m. Voters are not limited to only voting in the precinct where they are registered to vote:

Stagecoach Trail, Northwest Conference Rooms San Marcos, TX 78666. Early voting by personal appearance shall be conducted during the following stated dates and times (excluding holidays) at the following locations:
