

Role of P&Z In Capital Improvement Program

- Established in Charter
- "Submit annually to the city council, not less than one hundred and twenty days prior to the beginning of the fiscal year, a list of recommended capital improvements found necessary or desirable."
- Tonight Public Hearing & Discussion
- Approve recommendation May 11th



Discussion on 2022 CIP – General Funds

- Unclear on revenue impacts of COVID & state legislative changes on City tax collections
- 2022 General Fund limitation of <\$8 Million
- Affects both Multi & General Fund projects
- Projects \$750,000 >\$1,000,000 = \$3.7 Million
 - #525 Wallace Addition Subdivision design
 - #704 Dunbar Utility Improvements pavement reconstruction
 - *#*773 Fire Department Engine Replacement
 - #419 Sessom Academy Intersection pavement reconstruction

Discussion on 2022 CIP – General Funds (cont'd)

- Projects \$250,000 \$750,000 = \$2.35 Million
 - Transit Bus Replacement- \$440k*
 - #740 River Parks ADA Improvements
 - #475 City Facilities HVAC Replacements
 - #169 City Parking Lot Replacements
 - #526 City Facilities Major Maintenance
 - #753 City Facilities Roof Repairs/Maintenance
- Remaining Projects < \$250,000 = \$2 Million
 - #616 Cemetery Improvements
 - #725 Fire Station 1 Remodel
 - #743 Rio Vista/Dog Beach Repairs
 - #732 Animal Shelter
 - Future Bond Projects (#464, 655, 656)



Follow-up on FY21 Recommendations

- Expedite #650 Sessom Shared Use Path to within 3 yrs
 - Buffered bike lanes in Sessom/Academy
- Expedite #464 Old RR 12 to FY2021
 - Seeking federal funds or bond project
- Expedite #8 Fire Station Airport to FY2021 or 2022
 - Funding limitations bond project
- Expedite #739 Dunbar Education Building to 2021
 - Currently working with HPC



Follow-up on FY21 Recommendations

- Road Improvements along Old RR12 between Blanco and Holland
- Note importance of the following projects: #464 Old RR12, #712 Downtown Ped Safety Imps, #681 Hills of Hays, #732 Animal Shelter
- Support pedestrian and bike improvements and overall Safety on the following projects: #464 Old RR12, #419 Sessom/Academy, #480 Hopkins Sidewalk, #594 Hopkins St. Imp Moore to Guadalupe, #629 IH 35 Utility Relocations

Discussion on 2022 CIP – Stormwater Funds

- New rate structure initiated last year verifying revenues
- Council direction to limit annual rate increases to 6.5%
- Debt limit < \$6 Million
- Projects \$500,000 >\$1,000,000 = \$4.6 Million
 - Sunset Acres Subdivision regional detention construction
 - Castle Forest Channel construction
 - River Ridge Stormwater design & acquisition
 - Wallace Addition Subdivision design
- Remaining projects design and construction funding



Discussion on 2022 CIP – W & WW Funds

- Maintain/reduce CIP amounts assumed in last year rate study
- Reduces potential rate impacts with new water supply improvements coming on-line
- Projects \$750,000 >\$1,000,000 = \$15.3 Million
 - #419 Sessom Academy Improvements construction
 - #414 Hwy 21 Water construction
 - #556 Comanche Pump Station Imp construction
 - #704 Dunbar Utility Improvements construction
 - #563 Linda Lane Improvements construction
 - #707 Sessom Creek Imp. Phase 2 construction
 - #427 Main Lift Station Replacement design
 - #780 Weatherization & Performance Hardening design/const.gov



Discussion on 2022 CIP – Electric Funds

- Coordination of work with other CIP projects
- Overhead to underground conversions
- Improvements to distribution reliability
- Projects \$750,000 >\$1,000,000 = \$4.5 Million
 - #760 CA-30 Circuit Creation
 - #563 Linda Drive Improvements
 - #749 Underground Electric conversions
- Projects \$350,000 \$750,000 = \$1.5 Million
 - #770 Zone 1 Pole Replacement
 - #644 Sunset Acres Subdivision
 - #783 Lime Kiln Underground Conversion
- Remaining projects approximately \$1.3 Million



CIP Future Bond Project Selection

- General fund debt capacity limitations
- Potential bond projects have been identified in the 2020, 2021 and 2022 10-year CIP plans (shaded light blue.)
- Council direction for substantially designed projects to avoid significant project changes after approval
- CIP funding limitations prevent full design and final property acquisitions prior to bond approval
- Goal to have project pool have reached at least 30% design status
