# **Tax Exemptions**

- Removes part of a home's value from taxation
- Exemption is a set dollar amount reducing the home's taxable value
- <u>City currently offers an over 65 and disabled homeowner exemption</u>
- City does not offer a homestead exemption



# **Homestead Tax Ceiling**

- Limits dollar amount of taxes paid or places a ceiling on the taxes paid
- Tax ceiling set equal to the dollar amount of taxes paid the year the homeowner qualifies for the ceiling
- Tax paid will not exceed ceiling unless improvements are made or homeowner is no longer eligible
- Ceiling is adjusted if tax rate or taxable value decreases resulting in less taxes than original ceiling
- Increases to tax rate, even voter approved, will not change the ceiling
- Once the tax ceiling is adopted it cannot be repealed
- City does not currently offer



# **Current City Exemptions**

#### • 65 or Older

- \$25,000 Exemption
- Homeowner eligible when they turn 65 and file an application for the exemption
- \$281K FY2021 total taxes exempted for a total of 1,982 homeowners
- Disabled
  - \$25,000 Exemption
  - Homeowner must meet the definition of disabled for disability insurance benefits
  - \$14K FY2021 total taxes exempted for a total of 108 homeowners

#### 100% Disabled Veteran

- 100% of value exempt
- Homeowner must meet the definition from US Dept. of Veteran Affairs
- \$193K FY 2021 total taxes exempted for a total of 130 homeowners

### **City Scenarios Based on Tax Year 2020**

- Increase over 65 exemption by \$10,000 to \$35,000
  - Save the homeowner \$59.30 annually
  - General Fund revenue reduction of \$118K
- Implement Homestead Exemption of \$25,000
  - Save the homeowner \$148.25 annually
  - General Fund revenue reduction of \$735K
- Implement Sr. Tax Ceiling
  - No impact to TY2020 but as assessed values increase there would be incremental savings to homeowner
  - No impact to TY 2020 but as assessed values increase there would be a reduction in revenue to the General Fund



## **Next Steps**

 If choose to modify exemptions or tax ceiling Council would need to approve an ordinance to amend Section 78.077 of the City Code effective with the Fiscal Year 2023 budget
