ZC-21-01 (100 Block Centerpoint Road/Sendero at Centerpoint Multifamily) Hold a public hearing and consider a request by Teresa A. Shell, Generation Development Group LLC, on behalf of Mark B. Randolph, for a zoning change from “FD” Future Development to “CD-5” Character District-5, or subject to consent of the owner, another less intense zoning district classification, for approximately 6.698 acres out of the Edward Burleson Survey, No. 18, Abstract No. 63, Hays County, Texas, located in the 100 Block of Centerpoint Road.

The San Marcos Planning and Zoning Commission will consider the above request at an upcoming public hearing to obtain citizen comments and will either approve or deny the request. This recommendation will be forwarded to the San Marcos City Council. Before making a final decision, the Council will hold a public hearing to obtain citizen comments.
