

**ORDINANCE NO. 2021-44**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS AMENDING THE CITY'S 2020-2021 FISCAL YEAR BUDGET TO ALLOCATE \$41,705 FROM STATE SEIZED ASSET FUNDS TO PROVIDE FUNDING FOR THE PURCHASE OF EQUIPMENT FOR THE CRISIS NEGOTIATIONS TEAM, GPS TRACKERS FOR CID PERSONNEL AND DRONE MAPPING SOFTWARE; AND PROVIDING AN EFFECTIVE DATE.**

**RECITALS:**

In accordance with Section 8.16 of the City Charter, the City Council declares that a public necessity exists that requires an amendment to the City's 2020-2021 Fiscal Year Budget.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN MARCOS, TEXAS:**

**SECTION 1.** The City Budget Ordinance for the 2020-2021 Fiscal Year is amended as set forth in the attached Exhibit A, to allocate \$41,705 from State Seized Asset Funds to provide funding for the purchase of equipment for the Crisis Negotiations Team, GPS trackers for CID personnel and drone mapping software.

**SECTION 2.** These revisions will be incorporated into the 2020-2021 Fiscal Year City Budget.

**SECTION 3.** If any word, phrase, clause, sentence, or paragraph of this ordinance is held to be unconstitutional or invalid by a court of competent jurisdiction, the other provisions of this ordinance will continue in force if they can be given effect without the invalid portion.

**SECTION 4.** All ordinances and resolutions or parts of ordinances or resolutions in conflict with this ordinance are repealed.

**SECTION 5.** This ordinance will take effect immediately after its passage, approval and adoption on second reading.
