ZC-21-07 (parcHAUS) Hold a public hearing and consider a request by LJA Engineering, Inc, on behalf of Lowman Ranch, Ltd, for a Zoning Change from General Commercial (GC) and Future Development (FD) to Character District 5 (CD-5), or, subject to consent of the owner, another less intense zoning district classification, for approximately 9.66 acres out of the Edward Burleson Survey, Abstract No. 63, generally located 1,050 feet west of the of the Centerpoint Rd and Center Point Ct. intersection (W. Rugeley).
