PUBLIC HEARINGS

2. CUP-17-06 (Rumors Bar) Hold a public hearing and consider a request by Rumors Bar San Marcos, LLC, on behalf of G&S Development LLC, for a new Conditional Use Permit to allow the sale of mixed beverages for on-premise consumption at 1617 Aquarena Springs Drive. (A. Brake)

Chair Garber opened the public hearing.

Alison Brake, Planner, gave an overview of the request.

Taylor Henry, 1617 Aquarena Springs Drive, made himself available for questions. No one else spoke and Chair Garber closed the public hearing.

A motion was made by Commissioner Porterfield, seconded by Commissioner Kelsey, that this Action Item be approved with the following conditions; The motion passed by the following vote: the permit shall be valid for one (1) year, provided standards are met, subject to the point system; no live music (acoustic or amplified) shall be heard or allowed on the patio; a six (6) foot privacy fence shall be maintained between the adjacent apartments; the permit shall be effective upon the issuance of the Certificate of Occupancy; and the permit shall be posted in the same area and manner as the Certificate of Occupancy.
