V. 30 Minute Citizen Comment Period

Vikash Patel, addressed the Council on behalf of the hospitality industry and spoke about the cost of service going up and the need to find alternate revenue streams. He supports the Wonder World Park Conditional Use Permit and allowing them to sell alcohol to their customers.

Joel Barnard, addressed the Council as a 40 year resident and a neighbor of the Wonder World Park, and his opposition to the request of the applicant to sell alcohol. He stated that he was shocked when he read in the Daily Record the public notice of their request to sell alcohol at late hours in this neighborhood. He stated that this family centered park does not need to sell alcohol.

Kevin Carswell, addressed the Council as a long time resident and business owner in San Marcos and spoke in favor of the Conditional Use Permit being provided to Wonder World Park. He stated that he feels that with the amount of restrictions that the Planning and Zoning Commission placed on them that they can continue to be good stewards to the neighbors.

Thea Dake, addressed the Council in opposition to the Conditional Use Permit for Wonder World Park. She feels it is inappropriate for the Chamber to advocate for this and politicizing this issue. She said that this is not appropriate in the neighborhood. She urged the Council to overturn this decision. Please do not open a Pandora's Box.

Sharon Lawrence, addressed the Council on behalf of the 100 block of Hughson Court that is posted on the agenda. She provided explanations of the impediments and the parking space issues. She hopes Council can do something to help make this area safer. She expressed her gratitude for funding the sidewalks on Craddock and indicated there is a speeding problem here as well.

Shannon Mattingly, provided a brief update on this zoning change request.

She informed council that a Preferred Scenario Amendment (PSA) is not required since the property is over 20 acres. This will be developed as a continuing care and retirement facility.

Mayor Thomaides opened the Public Hearing at 9:15 p.m.

Those who spoke:

Charles Johnson, spoke about his experience with healthcare and elder living. He spoke about how well the church and the developer meet each other's dreams for this property. They agree that a public road through the development would be an unsafe situation. He stated their concerns with having a public trail and access and explained that this is not a public park. He asked that the safety of the residents be considered.

Kendall Bell-Enders, spoke against this zoning change. She encourages council to maintain the current zoning of this area. She feels this benefits the church and not the entire community. A large mixed use development is out of character for this area. This will be a big deal for those that live on West McCarty Lane due to traffic, she would like to ensure a traffic study is done.

Gerald Faldyn, Spoke as a principle with Halcyon Concepts, developer of proposed site and explained their vision of this property. It would be a senior and disabled living facility and would offer something that caters to the individuals that will be residents in these facilities. He asked for councils support regarding a variance in order to control access to these facilities that would provide a private and secure setting. He thanked staff for their collaboration and effort in this process. He also stated public sidewalks would be installed as required.

Beth Knox, worked in senior care services for over 30 years and agrees with the comments made by Mr. Johnson and Mr. Faldyn. This will be an asset to our community which will help promote healthy aging. She stated the pace will be slower in this community as most residents will use scooters, canes, and walkers. She asked that council consider removing any public parking through this development. She stated that codes do not make neighborhoods, but people do.

Marian Upchurch, spoke as a potential resident for this facility. She stated this is needed in this town desperately. This is not a typical open environment, this is meant for elders and she would like to have a sense of security. She would

like to get on the trail safely, return safely and not have to compete with others on the trail.

15. 7:00PM Receive a Staff presentation and hold a Public Hearing to receive comments for or against a request by Brenda and Kaare Remme to appeal a decision made at the October 10, 2017 Planning and Zoning Commission meeting, in which the Planning and Zoning Commission granted a Conditional Use Permit (CUP-A-17-01) for the sale of beer and wine for on-site consumption to Wonder World Park, located at 1001 Prospect Street; and consider action related to the appeal, by motion.

Shannon Mattingly, Director of Development Services, provided a brief presentation of the CUP requested by Wonder World Park. The request was to allow alcohol sales within certain boundaries within the park.

Phillip Schmandt, attorney representing Brenda and Kaare Remme addressed the Council regarding their opposition to the issuance of the CUP to Wonder World Park. He spoke about the issue of the application being incomplete. He stated that the application being incomplete is a violation of Section 4.3.4.2 of the Code of Ordinances. He spoke about his concerns with Christmas lights that are now on the tower and his understanding that the Park is grandfathered and doesn't have to adhere to the lighting trespass standards in the code. He encouraged the Council to approve the appeal as requested.

Kristin Mostyn Williams, addressed the Council regarding her desire to operate the Wonder World Park as an event center and theme park. She does not want to see such a historical facility sold. The area she wants to sell beer and wine is in a separate building from the main entrance to the cave, and she asked for an allowance of a CUP for one year to prove herself. She spoke of the Christmas lights on the tower and informed council these are here because they are about to have a holiday event at the Park. She said they would work with any of the neighbors to ensure that all issues are met.

Mayor Thomaides opened the Public Hearing at 7:20 p.m.

Those who spoke:

David Nicosia, stated that is home is block away and can see the tower and hear noise from his yard, if the hours are extended he loses privacy. He would council to reverse the Conditional Use Permit.

Kaare Remme, purchased land next to the daytime amusement park a few

years agos. They were aware of this, but it was not an adult entertainment busines operating in the daytime and evening hours with noise, light pollution, and drinking on the premises. This is a way to radically change the use of this property.

Buddy Mostyn, president of Mostyn Enterprises and owner of wonder world park. He apologized to the neighbors regarding the recent trash issue. He noted there have never been neighbors that could see this area, but they have taken care of this. He has run the park for 45 years and will now turn it over to his daughter to run. He mentioned Allen Street and how there are a lot of issues not conducive to a residential neighborhood like college kids and block parties. He mentioned he had a beer and wine permit when he owned the property and never had problems. He also stated he served on CVB board, Chamber, and Sponsored many events in the community.

Cindy Brown, mentioned trash concern and noted it is still there. Major concern is the six foot fence. This will not create a boundary that is private. She does not want a bar in her backyard.

James Baker, spoke against Conditional Use Permit (CUP) and the inappropriateness to have a bar in a neighborhood and the loud music that can be heard. He doesn't understand why everyone needs to sell alcohol to stay alive in business. Look at other options to make money. He asked that the Council look at the value of the neighborhoods and not just businesses.

Jason Mock, Chamber of Commerce President, spoke in favor of the business owner and the CUP. Allow this business that has been around for over 100 years a chance to prove they will be responsible neighbors with this one year CUP.

Jake Walden, spoke about the concerns revolving around the flow of traffic. He has not heard any discussion regarding traffic and he is in agreement with the concerns of his neighborhood.

Roland Saucedo, huge advocate for neighborhoods and has concerns with the safety issues that selling alcohol in this area could have. Wonder World is right in the center of several neighborhoods and council made a commitment on several occasions to uphold the integrity of these neighborhoods. He suggested they open a putt putt course and not sell alcohol. He asked council to please overturn decision made by Planning &Zoning Commission to issue CUP.

Cathy Dillon, conflicted on this issue because she recognizes how important Wonder World is to tourism for the community and how wonderful the Mostyn's are. This park needs to survive but in a reasonable manner. She stated that people have a right to sleep and not have drunks and wrecks in their neighborhood. She is torn on this decision so she requests that council possibly table this item and come up with other solutions.

There being no further comments, the Mayor closed the Public Hearing at 7:40 p.m.
