# Meeting Minutes City Council

## I. Call To Order

With a quorum present, the regular meeting of the San Marcos City Council was called to order by Mayor Thomaides at 6:02 p.m. Tuesday, September 18, 2018 in the City Council Chambers, 630 E. Hopkins, San Marcos, Texas 78666.

# II. Roll Call

Marlene Moriarity, introduced herself to the community and Council and is submitting her application for the Commission on Children and Youth. She is excited for the opportunity to work for and with the children in the community. She enjoys what the community has to offer and looks forward to giving back.

Sharri Boyett, addressed the Council regarding the San Marcos Regional Animal Shelter. She expressed her appreciation for the extra funding, but reminded Council that the killing will not stop with the new budget additions alone. She passed out pictures to give the issue "a face". She provided information on the next steps needed and how a no kill resolution needs to be approved and adopted and regional goals need to be set for a 2020 program. She asked about the adoption trailer because it was granted months ago. The shelter lacks transparency and marketing to show the pets online. There must be a call for an increase in fostering animals and provide resources for those looking to surrender their animal. The shelter staff could do so much more and

sure they may be under staffed, but that is not a good excuse. There are benefits to no kill and this is what the citizens want.

Kate Shaw, expressed her appreciation to the City Manager, Staff and the Council for making the Animal Shelter a priority and the increases in the budget is great. This is a big step but a declaration of 90% live outcomes needs to be created. There is concern with funding and what funding needs this may bring up but we should expect the other entities that contribute would be willing to contribute more to see better outcomes. She urged the Council to continue keeping the Shelter front and center.

Mario Garza, addressed the Council and thanked the Mayor for putting item #23 on the agenda. Many Cities and States have already recognized this and he thanked the Council for taking a vote on this issue. He stated that this day will start by honoring all of the Indigenous people that were destroyed by Columbus when he started the slave trade. He stated that Columbus never actually set foot in the Americas. The native people were highly developed but were destroyed when the Europeans came. There was an estimate that 100 million Indigenous people were in this country and there are now only 2 million remaining.

Jordan Buckley, spoke as the campaign manager for Dr. Jocabed Marquez, who asked him to read the following words, as it is her husband's birthday and they have family in town to celebrate:

"Good evening, Council. I wish to contribute my thoughts on two decisions in front of you tonight. First, to convey my gratitude for the prudent step forward in support of the budget consideration that would enable hiring of a full-time vet tech and volunteer coordinator at the Animal Shelter and to extend hours slightly. However, I agree with concern that Saturday is a better day to stay open later — it accommodates the schedules of many working people. I'm delighted to learn that Mr. Bert Lumbreras, our City Manager, has been taking meaningful steps toward shelter improvements. Thank you, Mr. Lumbreras.

I stand with Fix Hays County & Animal Advocates in calling for a 90% live-outcome rate; enacting immediate documentation and online sharing of animals entering the shelter; low and no cost neuter and spay programs as well as general dedication to the path charted via the widely successful No-Kill Equation.

Lastly, I wish to express my enthusiasm for adoption of Indigenous People's

Day. Because water is life and our springs are sacred, the community today called San Marcos has been steadily populated longer than perhaps any other place in Abya Yala. My husband, daughter & I have lived in San Marcos for 6 years, by way of the Rio Grande Valley; my ancestors are Coahuiltecan and Lipan Apache, who migrated and who lived in this area of Tejas for over 13,000 years. The Sacred Springs are the birth place of our indigenous people in San Marcos.

My passion for protecting our rivers and natural ecology isn't just a platform point; it's a familial obligation and spiritual duty. As an educator who recently attained my doctorate, I can faithfully assert that Cristobal Colon, or Christopher Columbus, is no hero. His own travel journal attests to his brutality — from enslavement to sexual violence — and the Western bias of our educational & political systems have pushed the notion that a European who never even arrived anywhere today considered the U.S. somehow merits our celebration. When genocide and enslavement of the Taino people exterminated most their population, colonizers began enslaving Africans and bringing them to work on sugar plantations, known as white gold. It is a very important issue for me: our indigenous population is still here in San Marcos — not all of us were exterminated, but our voices have been silenced for so long. We have had to compromise our lands, our dignity, our identity. It is time for the leadership in San Marcos to be responsive to the atrocities long inflicted on Indigenous People in San Marcos. It is time for restitution. It is time for our culture to be acknowledged, celebrated, and honored.

Texas State was right to concede to protestors in removing the roadside Jefferson Davis Confederate Memorial in 2016 and San Marcos— a beacon of indigenous legacy, both for our unique history and as home to the Sacred Springs Pow Wow — should act to cancel Columbus Day permanently."

Ezekiel Enriquez, addressed the City Council regarding his issues with Code Enforcement. He stated that he feels that there are two sets of laws, one for Hispanics and one for white people. He stated that he has spoken to multiple people on City Staff and the Mayor regarding an issue with a car being illegally parked on his street and stated Hispanics are red tagged right away if this is their vehicle. He said fixing a car can cost \$250.00 and Hispanics don't have the luxury to pay for this just to have it towed. He asked the Council to do something about this. He asked what are we paying code enforcement for, we the citizens are paying your salaries and we should all be treated equally.

Marc Bech, read a statement on written by Jennifer Hayes, who was unable to attend tonight's meeting, but wanted to be heard:

"My name is Jennifer Hayes and about 17 years ago, I started helping local animal shelters and rescues as a volunteer photographer. I'm blessed that my passion for animal welfare has resulted in employment, and now I've worked for over a decade for Best Friends Animal Society, currently as their web content editor.

Because of my involvement with Hays County Animal Advocates, in February I signed up to volunteer at the San Marcos Regional Animal Shelter. Unfortunately, my photos weren't uploaded for up to a week after I provided them. For months I've asked to take over that task and post my photos directly to the shelter's website, bypassing staff, thus saving the city both time and money. For months I've received no response - that is until last Thursday.

When I arrived for my weekly photo shoot, I was told I needed to meet with the shelter manager Kara Montiel. She informed me that due to policy, volunteers and even unpaid interns, don't have that authorization. Additionally, they were eliminating the volunteer photographer positions and replacing them with a paid photography internship. She told me to not return this Thursday, but since I was already at the shelter, could photograph animals that day.

For over six months, I've been photographing the adoptable cats, dogs and even guinea pigs, supplying the shelter with over 1,800 edited and ready-to-publish images within hours of them being taken – for free. We're repeatedly told how the shelter is understaffed and underfunded, yet now I've been instructed to stop offering my time and talents at no cost, despite my desire to continue. That breaks my heart.

However, the real losers in this scenario are the animals. It's my understanding that shelter staff will supply photos until the new position is filled. I urge you to take a look at the shelter's website now and guarantee you'll be able to tell the difference between my and the other volunteer photographer's images vs. the staff's intake photos. If not, I'll be more than happy to email you some examples.

In fiscal year 2017, 26 percent of the dogs and 69 percent of the cats who entered the shelter were killed. Those animals deserved homes with loving families. While it's too late for them, it's not too late for the animals at the shelter now ... and next week ... and next month.

In FY2017, only 18 percent of the dogs and 9 percent of the cats were adopted from the shelter. That's a significantly lower number than those killed. That's why I volunteer. A quality photograph can quite literally mean the difference between life and death for a shelter animal. Photos that capture an animal's personality create an instant connection with the viewer and often those connections result in adoptions.

If, as the shelter's new mission states, is truly to "care for, protect and find quality homes for abandoned and neglected animals," wouldn't denying me the opportunity to offer my photography skills to the shelter for free, be in direct opposition to their mission?

Join me and be a voice for the animals. As city council members, please use your power to help put an end to the shelter staff's obstructionism and help save lives. Thank you."

Direction: to provide the following language in Section 2.423 (c) 4: requiring prompt disclosure of the interest triggering the recusal, if the person is a member of a city board or commission, to other members of the board or commission, and leave the room in which the board or commission is meeting during the board or commission's discussion of, or voting on, the matter.

Direction: to place signed affidavits on the website from the date of adoption

of this Ordinance.

29. Hold discussion regarding limiting the number of bedrooms in the Duplex zoning category or anywhere else that this should properly be done in the Code, and provide direction to staff.

Council Member Hughson provided the introduction to this discussion. Council noted during a recent rezoning case that there is not currently a limit on the number of bedrooms and there seemed to be a need for a discussion on the topic.

Council direction was to send the issue to Planning and Zoning Commission to look at the Duplex zoned lots.

Planning Director Mattingly will check other cities to see how they handle duplexes.

VI. Question and Answer Session with Press and Public.

Roland Saucedo, asked that during the last month while Parks and Recreation was holding their public meetings in regards to the the Parks Master Plan it was stated the City had no site projected for relocation of the baseball fields. Does the Parks department not know?

The Mayor responded and stated that the Parks Department has not been part of the discussions related to Project World Series.
