**Background Information:**

This request is to approve a contract between the City of San Marcos and WEX Bank located in Carol Stream, Illinois, for provision of a fleet fuel card management system. The card program is managed between WEX Bank and Enterprise Fleet Management to allow for greater metrics collection as the City has a separate current agreement with Enterprise Fleet Management for lease of fleet vehicles.

The fleet fuel card management system will allow for the purchase of fuel (gasoline & diesel) for City vehicles and equipment in the estimated annual amount of \$1,389,551.60.

As part of the City's new agreement with WEX Bank and subsequent issuance of the new cobranded fleet fuel cards, the City is able to take advantage of the agreement between WEX Bank and Enterprise Fleet Management for complementary enhanced reporting. The enhanced reporting includes Telematics, Fleet Monitoring, Fuel Management, Driver Usage and Maintenance Needs.

The new WEX Bank contract includes the following fees based on approximately 300 cards as well as a rebate program. The City intends to allow automatic renewals of this contract in one-year increments for a total contract term not exceeding ten (10) years.
