Background Information:

The Blanco Riverine Flood Mitigation project is one of the CDBG-DR&MIT funded projects to provide for a reduction in flooding after the 2015 flood events. This is an approximately \$20.4M project consists of a berm/ floodwall structure located between River Road and the Blanco River to contain flood waters up to the 50-year flood event; thereby preventing the Blanco River from overflowing into the Blanco Gardens neighborhood. Property acquisitions required for the project have been underway since Summer 2020. All acquisitions must be in compliance with the Texas Landowner's Bill of Rights and federal acquisition requirements in order to provide a fair resolution to the property owner.

This acquisition is necessary for the stormwater outfall and the City has been unable to reach agreement with the property owner. The property owners have retained legal representation and this resolution is necessary to continue the required process for the acquisition. The owners have been notified of the posting of this item and adoption of the resolution does not preclude further negotiations in an effort to resolve this matter.
