- City council passed a resolution creating the San Marcos Urban Transit District for the San Marcos urbanized area - August 2019
- The Federal Transit Administration concurred on September 11, 2019 that the City is the direct recipient, effective October 1, 2019
- This resolution provides Council’s authorization for the City Manager, or his designee to execute documents, including Signature Authority, with the Texas Department of Transportation (TxDOT)
- The TxDOT Signature Authority document indicates which agency personnel may serve in which roles for grant administration between the City and TxDOT on an annual basis
