Background Information:

On November 28, 2017, the City discovered a water line break on the main feed to the Activity Center, which was in an undetermined location underneath the building. As a result, the Activity Center remained closed for several days. The Fence Lady, Inc., located in Boerne, Texas, was secured immediately to begin work, which included tunneling under the building to make a trench 9 feet high by 3 feet wide and 135 feet long to access the source of the water line break. Multiple water line breaks were located and the broken pipe was replaced. This is to ratify an emergency contract to The Fence Lady, Inc. in the amount of \$83,680.
