**Background Information:**

This project includes construction of various improvements to enhance pedestrian and bicycle mobility along the North Bishop Street corridor from Prospect Street to Belvin Street. Improvements include a proposed five-foot sidewalk, restriping of North Bishop Street to include a five-foot bicycle lane, and an eight-foot by twenty-foot concrete pad to accommodate a future bus stop. Landscaping and irrigation improvements will also be included around the future bus stop.

On June 7, 2018, the City received four (4) bids for the N. Bishop Street Sidewalk Project issued in accordance with City Purchasing Policy and Local Government Code. After evaluation by City staff and engineering consultant, Riley Sladek, P.E. of LJA Engineering, Inc., award is recommended to Winters Construction, Inc., San Antonio, Texas, in the amount of \$288,446.72 for the Base Bid plus Additive Alternates A and C. Alternate A is the pavement repair and Alternative C is for extended plant maintenance.
