This is a City Council workshop to discuss and provide direction on the calculation and creation of the Fiscal Year 2019 budget.

In this workshop, City Council will receive detailed information on revenue and expenditure recommendations for the FY2019 budget. This may include discussions on assumptions and potential projects from all funding sources included in the preliminary budget.

The budget process begins in the spring with formation of the Budget Policy. A preliminary budget is presented for discussion with City Council during workshops held on June

13 and June 14. Changes made during the workshops are incorporated in the Proposed Budget that is filed with the City Clerk by the end of July.

Public hearings and further discussions are held in August and September and changes can be made to the budget until the adoption on September 18th.
