Background Information:

This item is to hold a public hearing and amend the CDBG-DR Action Plan to allow reimbursement to the San Marcos Public Housing Authority (SMPHA). Council is not voting or allocating the funds at this time. Staff will process the application according to HUD regulations and bring back eligible cost reimbursement at a later date.

The City of San Marcos was awarded \$33,794,000 to address the impact of the floods of 2015. SMPHA has requested \$866,603 proposed reimbursement for repairs and use of SMPHA funds for public housing units during the 2015 floods. Currently, the Action Plan does not allow for reimbursement of funds or for funds to be allocated to the SMPHA. The proposed Substantial Amendment No. 7 to the Action Plan will allow reimbursement of 2015 flood-related eligible CDBG-DR funds to SMPHA.
