### Background Information:

This is a contract for testing, inspection, and minor repairs of approximately eight hundred and eleven (811) Current Transformer meters. The initial term of the contract is for two (2) years, with a one (1) year option to extend. The first year of this contract of the two-year term will be for an amount not to exceed \$36,000.00, and the second year for an amount not to exceed \$35,992.47. The second year of the contract and the option one-year term, if exercised, will be initiated by a notice of contract renewal by the Purchasing Manager. The contract will be effective on October 1, 2018 through September 30, 2020.
