Background Information:

This change in services is for design services from CH2M Hill / Jacobs for the next round of improvements at the Wastewater Treatment Plant. CH2M will initially provide services for this project to the 30% design level to obtain accurate cost estimates for the different elements of the project as well as pre-design services.

Phase 2 of the project being proposed consists of the following:

- Additional fine screen and conveyor at headworks
- Roof replacement over the grit classifier and screenings handling area
- Sludge drying bed rehab (the beds are no longer used for sludge drying but are used by W/WW, Transportation, & SMEU for various vac-truck wastes)
- Primary sludge screening
- Covers for secondary clarifier launder
- Replacement of two existing sludge centrifuges & associated conveyors
- New blower building for housing high speed blowers and one additional high speed blower

CH2M is proposing to conduct this work for a total of \$157,795. We would like to have the cost estimates available to get the project on the CIP schedule to complete the remaining design work in 2019 and construct in 2020.
