Background Information:

In June 2017, City Council approved a list of qualified engineering firms to provide professional engineering services in connection with CDBG-DR Infrastructure Projects as needed (Resolution 2017-100). From this list, Brown and Gay Engineers, Inc., was selected to provide preliminary engineering services, final design, and construction phase services for the East Aquarena Drive Reconstruction.

Brown and Gay Engineers, Inc. has been chosen to provide required Engineering Services for the East Aquarena Springs Drive project which includes an existing horizontal curve near the Villagio Apartment Complex that is currently superelevated in the wrong direction. The project scope includes engineering services for the reconstruction of East Aquarena Springs Drive at this curve to reverse the superelevation of the road, allowing for improved traffic flow and eliminate the current safety hazard. The project will also address drainage issues in the area. Engineering and design services are expected to be completed in June 2019.
