#### **Background Information:**

Dewberry will allow the City of San Marcos to access and use more accurate and up-to-date Nearmap aerial imagery by providing a far higher resolution and very short turnaround time of two weeks. The imagery will enable GIS Analysts to provide City departments more accurate mapping services through various GIS applications throughout the City.

The City compared three different imaginary solutions: CAPCOG (current vendor), Google and Nearmap. After comparing the various features offered by the three vendors. Nearmap was selected for the following reasons: can contract with Nearmap to provide imaginary either in the fall or spring, higher resolution (2.8 inches), access to imaginary within two months.

The City will contract with Nearmap to provide imaginary for the Spring of 2019.

The Texas Comptroller of Public Accounts Department of Information Resources (DIR) awarded a contract (DIR-TSO-3389) to Dewberry Engineers Inc for Geospatial Products (Imagery), Custom Geospatial Data and Services. City staff recommends awarding a contract to Dewberry Engineers Inc. for a 36-month subscription to Nearmap ArcGIS Aerial Imagery Software for a total of \$53,985.63.
