This is a voluntary annexation request submitted by Transportation Alliance for approximately 934.34 acres comprised of six separate tracts of land along State Highway 80 and FM 1984. City Council approved a 380 agreement for the Katerra Development, which is part of the larger tract, on October 16, 2018.

Maxwell Water Supply and the City of San Marcos will provide water services to the site. The developer will connect to City of San Marcos wastewater lines, which are being extended to the area through a CIP. Bluebonnet Electric Cooperative will provide electric service to this development.

The City of San Marcos will provide Police, Fire, and EMS services to the site.
