**Background Information:**

**A) Citizen Utility Advisory Board**

An ordinance was recently brought before Council amending the composition of the Citizen Utility Advisory Board. We are seeking appointments to fill the following positions: (1) citizens at large and endeavor to appoint (3) members with experience as a licensed professional engineer, experience in the operation and management of public utility systems or education and experience in finance or accounting.(1) City Council Member

We have three applicants that fit the experience in utility systems, finance/accounting, and an at large member roles. There is currently one at large member that is seated on the board. There will be one vacancy that remains, but we will fill this role as more applicants apply.

**Applicants include:**

1. **Gabriel Garcia** - Has served 2 consecutive Terms, but has a great deal of knowledge that is exceptionally beneficial because he has, experience in the operation and management of public utility systems.
