Background Information:

On December 20, 2016, City Council approved an Amended and Restated Interconnection Agreement (ARIA) with LCRA Transmission Services Corporation and an associated Bill of Sale for the transfer of certain transmission infrastructure located at the Hilltop and Ranch Road 12 Substations. A purpose of the sale was to transfer assets that fell under the criteria for meeting NERC and ERCOT regulatory requirements, relieving the City of expenses and resource commitments to comply and minimizing regulatory exposure.

In late 2018, additional systems and components were determined to be a part of the LCRA bulk electric system (BES) and would also fall under regulatory requirements. The net value of the control houses and battery systems at Hilltop and Strahan Substations is \$10,248.13, which LCRA has agreed to pay the City and take on full responsible for these BES components.
