Background Information:

The City received proposals to finance twenty (20) Police Tahoes for the Police Department. Of proposals received with the best interest rate, U.S. Bancorp Government Leasing and Finance, Inc., offered an interest rate of 2.23% for a three (3) year term. The total amount of the vehicles is \$649,780 plus interest of \$29,193.24 is the total amount to be financed and paid by the City which is equal to \$678,973.23 at the conclusion of the three-year agreement. Payment will be made annually with the first payment due November 8, 2020.

Under separate October 15, 2019 Council Item is the procurement of the twenty (20) Police Tahoes from Johnson Grayson Automotive, Inc DBA Holiday Chevrolet, Whitesboro, TX.
