### **Background Information:**

This request is to renew and modify the Interlocal Agreement with Texas State University to assist the City's implementation of four Edwards Aquifer Habitat Conservation Plan (EAHCP) objectives (removal of non-native plants, Texas wild rice enhancement, Removal of Floating Plants and management of key recreation areas). The amendment makes the following changes to the initial interlocal agreement:

Extend the contract through December 31, 2027

Section 1 A. University Agreements:

1) a) Delete "IH-35" and add "Stokes Park" - EAHCP Phase 2 (2020-2027) extends these four objectives past IH-35 to Stokes Park

1) b) Delete entirely - EAHCP partnership with USFWS San Marcos Aquatic Resource Center for growing Texas wild rice plants (TWR) is no longer needed because TWR coverage goals are almost achieved

5) Deliverables - Delete "analysis of monitoring data on effectiveness of planting and/or gardening on success of TWR and native plant aerial coverage" and change to "observation of

effectiveness of non-native plant removal and native planting efforts”.

New objective added to enhance the efficiency of submerged non-native aquatic plant removal.

Contractor will remove mats of floating plants in their work area.
