**Background Information:**

Representatives of the City of San Marcos and the City of Martindale have been engaged in negotiations regarding the extraterritorial jurisdiction (ETJ) boundaries of the two cities. The agreement specifies areas to be released by each city from its previously claimed ETJ and provides for payments to be made by the City of San Marcos to the City of Martindale over the next 30 years from tax revenues derived from 161 acres of land within the S.M.A.R.T. terminal project that Martindale is releasing from its ETJ under this agreement to allow annexation by San Marcos.

It is anticipated that the agreement will be approved by Martindale on January 21, 2020. A final copy of the agreement was not available at the time of posting the San Marcos City Council agenda for its regular meeting on that same date.
