Background Information:
This proposed agreement is with Weston Solutions, Inc., and provides for the design of an extension of a 12-inch waterline along Highway 21 from Airport Drive to William Pettus Road. This project was recommended in the 2016 Water Master Plan to primarily support future development within the city's regional airport along the Highway 21 corridor. Additionally, this waterline will support the future fire training facility which will be located approximately half way between the airport offices and William Pettus Road. This project will also include the design of conduit for city fiber optic line(s) to support the airport offices and the fire training facility.
Weston Solutions, Inc. was selected from the On-call Water Wastewater Engineering list approved by City Council April 16, 2019.
Construction is currently scheduled to begin in 2022.
