The installation of shade canopies will provide much needed shade and protection to our equipment as well as allowing for an improved playground experience for our patrons during the warmer months of the year.				
Pursuant to Local Government Code 271.102 which authorizes the City to participate in cooperative purchasing programs, staff recommends award of this work to T.F. Harper & Associates, LP, Austin, TX, in the estimated amount of \$160,007.25 through the BuyBoard contract #592-19. BuyBoard issued a Request for Proposals, evaluated offers and selected T.F. Harper & Associates, LP based on best value.
