**Background Information:**

The Sustainability Committee, City Council and P&Z have received information from staff regarding potential water conservation enhancements by requiring separate irrigation system water meters in new development. Irrigation use of water for lawns and landscaping comprises more than half of total seasonal water use, and represents a major opportunity for water savings going forward.

The proposed plumbing ordinance changes would require a separate irrigation meter for new single-family residential properties, which matches the requirement for commercial and multi-family services that was adopted in 2006. This change will enable accurate metering of water used by automatic irrigation systems. Existing residential customers would be grandfathered and no retrofits would be required by these changes.

**Council Committee, Board/Commission Action:**

The Sustainability Committee referred this item to City Council on September 30<sup>th</sup>. City Council approved referral of this item to P&Z on November 4<sup>th</sup>. P&Z approved the proposed amendments on December 8<sup>th</sup>.
