Background Information:

During the regular meeting of the San Marcos City Council held on January 19, 2021, a majority of the Council provided direction to staff for this discussion item to be scheduled for the February 2, 2021 Council meeting. The purpose of this discussion is to allow Council to consider and discuss the passage of one or more emergency orders related to slowing the spread of COVID-19 in the San Marcos community. More specifically, the purpose of this discussion is to determine the will of the Council with regard to the passage of emergency orders that would be more restrictive on our citizens and certain businesses than what is currently provided in the standing Governor's Orders.

Despite the fact that the standing Governor's Orders have suspended some of the statutory authority granted to Mayors during states of disaster, some cities have made the decision to enact ordinances that are substantially in conflict and are more restrictive than the requirements contained in the Governor's Orders. The current Governor's Orders also prohibit counties and cities from passing such orders that are in conflict with his standing orders. However, as previously mentioned some cities have elected to act in ways contrary to these stipulations out of concern for the safety of the public in their communities.

This discussion item will provide an opportunity for Council to consider and discuss the various risks and benefits of this course of action and provide direction to staff.
