This is a City Council workshop to discuss the Fiscal Year 2022 budget including operating and CIP and provide a Fiscal Year 2021 Financial Update.

In this workshop, staff will provide City Council with an update on economic factors, FY 21 general fund projections and FY 22 general fund expectations and progress.

The budget process begins in the spring with formation of the Budget Policy. An update on the budget process is presented for discussion with City Council during workshops held on May 18 and June 29. Changes made during the workshops are incorporated in the Proposed Budget that is filed with the City Clerk by mid-August.

Further discussions are held in August and September with a public hearing in September. Changes can be made to the budget until the adoption on September 21st.
