Both the LCRA TSC and San Marcos Electric Utility have completed upgrades and equipment replacements in the Hilltop, Strahan, Ranch Road 12, Redwood, San Marcos, and Rattler Substations. LCRA also completed a new ring bus configuration at Ranch Road 12 Substation. The amended Interconnection Agreement corrects for new equipment and new equipment identifiers. No asset transfers or changes in points of interconnection are changed.
