The San Marcos River Foundation has expressed the desire for the land to be brought into the City Park system as open space. |
| City Staff briefed the City Council in Executive Session on May 4 regarding SMRFs desire for the City to potentially accept all or part of the property into the park system. City Council was supportive of the acceptance of the donation.  |
