**Background Information:**

Texas State University operates its own water system within its main campus and needs to paint and maintain the elevated storage tank that serves main campus. This interlocal agreement provides for a new connection from the City's water system to the TXSU water system to provide water for fire-fighting, if needed, while they operate with lower capacities in their system during this maintenance window. The agreement defines responsibilities and operational conditions for the interconnect and is contingent on TCEQ approval.

The City's Engineering and Utilities departments have verified the City system can provide back up fire suppression water services, within the limits of the Agreement, with no impact to City water system operations.

The Agreement will remain in effect for 24 months or until TXSU notifies the City that work is complete, whichever comes first.
