Background Information:  The Centro Cultural Hispano de San Marcos plans to apply for Hays County Parks and Open Spaces Committee (POSAC) bond monies to 1) create a new urban park or plaza with community gardens, an outdoo theatre and festival space, and 2) remodel and renovate the historic Southside School, which currently houses
the cultural center.  Centro is currently in discussions with the San Marcos Consolidated Independent School District (SMCISD)  School Board and staff regarding the purchase of their historic school and property where Centro located. If the property is available, Centro will request POSAC funds to proceed with the purchase and create a new urban park, outdoor performance and festival space, and renovated cultural center.
Centro is requesting the City's public support for the POSAC project as well as a collaboration with the City of San Marcos including the possible transfer of ownership of the park area, including management and maintenance, once the park is complete.
The Resolution associated with this item expresses the City's support of Centro's application for funding through the Hays County Parks and Open Spaces bond process. The Resolution also includes the City's commitment to explore available and feasible options to collaborate regarding the parkland.
