#### **Background Information:**

On 2/5/2013, City Council approved a development for the Lazy Oaks Development which was later named La Cima. On 9/16/2014, City Council approved an amendment to the development agreement which provided for the annexation of more than 2,000 additional acres. The second amendment to the agreement occurred on 5/15/2018 which increased the acreage and total number of dwelling units from 2,400 to 2,800. On 8/18/2020, City Council approved a third amendment to the agreement to include an additional 129.38 acres and to change the maximum amount of multi-family allowed to be based off the number of units instead of acres. That amendment changed the maximum allowed multifamily from 30 acres to 720 units. The purpose of tonight's amendment is to align with the 2020 amendment so that the number of multifamily units authorized within the first phase is based off 360 units instead of 15 acres.
