Background Information:

On June 20, 2019, agreement #219-297 was executed with MGT of America Consulting, LLC for Cost Allocation Plan for \$14,900 based on FY18 expenditures. The scope included preparation of Full Cost Allocation Plan, 2CFR Part 200 Cost Allocation Plan and WIC indirect cost rates for the City of San Marcos. The agreement was amended to include FY19 expenditures as well.

This authorization of change in services is to include preparation of City-wide full cost plan (based on FY21-22 adopted budget), two CFR Part 200 Cost Allocation Plans, WIC Rates (based on actual expenditures for FY 20 and 21) and Full Cost Plan for Electric Utility.
