**Background Information:**

A contract (219-294) was awarded to pest control services in 2019 following a solicitation where seven (7) bids were received. The contract was renewed annually for the first two (2) years of the contract.

This authorization is to renew the contract from December 23, 2021 through December 24, 2022 for the estimated annual amount of \$25,000.00. This annual amount results in the contract exceeding \$50,000 whereby requiring Council approval. Staff has determined that this will be the final option year exercised on this contract and in 2022, a new solicitation for pest control services will be issued.
